

Minutes of Town of Round Lake (Road Inspection) Board Meeting May 28, 2013.

Present: Chairman Dave Sanders, Supervisors; Rolfe Hanson, Kay Wilson, Marilyn Karns, and Stan Strainis, Clerk Kathy McCoy, and Town Employee Doug Laier.

1.) Chairman Sanders called the meeting to order at 9:05 a.m.

2.) Approval of Agenda.

Motion by Wilson: second by Strainis to approve agenda. Motion carried.

3.) Certification of Meeting Posting:

Clerk McCoy certified that meeting agenda had been posted as required on May 22, 2013.

4.) Conduction of Town road inspection.

The following roads were looked at and discussed:

Forest Service Road 319/ 320 – Gravel (Forest service will provide at cost) Current forest service gravel is at GG. Hauling distance problem. Need to work with forest service to obtain gravel from closer pit.

Moose Lake Road intersection to end (5.1 miles) – look at micro surfacing in 2014. Last ½ mile was double seal coated 4 to 5 years ago.

Forest Circle Drive (1.3 miles) crack seal 2013. Possible sealcoat 2014.

Louie's Landing Road (¾ mile) crack seal 2013. Possible sealcoat 2014.

Dam Bridge: Posted at 4 tons. Dam will be reconstructed in 2014 or 2015. If town is going to replace bridge it would be done in connection with Dam rebuild (Contract with same engineering firm). Current inspections recommendations for existing bridge were discussed along with possibly of replacing bridge (one vs. 2 lanes).

Fin & Feather Road (1/2 mile) – patch bad spots this year. To far deteriorated for seal coating to be effective. Look at re-paving when needed 5 plus years.

Pine Point Road: Culvert replacement (May 29, 2013) Need to patch after completion.

River Road (1/2 mile) - possible sealcoat 2014. Additional ½ mile to end (cold mix portion of road) has been seal coated once before. Sealcoating again discussed.

Town Parking Lot: Possible seal coat this year.

Chief River Road: Crack seal whole road & seal coat old section 2013.

Tiger Cat Dam Road: seal coat 2013.

Tiger Cat Road: Possible seal coat 2015

Echo Point Road: Sealcoat 2013. Reviewed areas that need wedging prior to sealcoating.

Tiger Cat Road Bridge: Reviewed settling of pavement approaches.

Motion by Karns to approve black top wedging as needed for Echo Point and Tiger Cat Rd (bridge area).
Second by Wilson. Motion carried.

Line striping (fog lines in addition to center lines) for Moose Lake Rd., Twin Lake Road, and McClaine Road was discussed.

5.) Review of Boat Landings for Ordinance posting proposes.

Moose Lake Boat Landings: Moose Lake Club – signage (no camping). Expanding of parking lot discussed.

Wolfe Island Boat Landing – signage (no overnight parking).

Tiger Cat Dam Landing: Boat Landing Rules metal sign in place.

Clear Lake Boat Landing - Metal Ordinance sign in place.

The board returned to town hall at 11:36.

A motion to adjourn was made by Karns. Second by Sanders. Motion carried.
