3. Discussion on New Ordinance 2024-02

Accept Town Clerks proposed changes.

B. ATV and UTV routes will be clearly marked with signs designating the beginning and ending of routes, as well as other directions as needed. Routes must be signed in accordance with NR 64.12(7) (c), Wisconsin Administrative Code. ATV/UTV signage on all town roads routes will be the responsibility of Sawyer County Snowmobile and ATV Alliance, and the Town of Round Lake Road Department. This responsibility will be approved by the town of Round Lake Board of Supervisors. The Sawyer County Snowmobile and ATV Alliance will be required to work with the town of Round Lake Board of Supervisors to make sure all signage is complete and consistent throughout the Town. ATV/UTV posted signs may not be on all town roads but will be posted on Town roads entering the township.
