9. Status / Update: On Public Hearing on TRH Ordinance at the HHS Committee on Tuesday, May 11, 2024:

10. Discussion / Possible Action: Environmental Impact Analysis Criteria:

Martin Hanson outlined Environmental Impact Analysis, document could be 10-100 pages, cost \$10,000-40,000. Also, discussed Environmental Impact Statement and Categorical Exclusion.

Levels of detail need to be defined by the board

Credentials of preparer need to be assessed

Reports should be done by a third party professional who should coordinate with the DNR if and when needed

11. Status / Update: on Subdivision Ordinance:

12. Status / Update: on Town Survey:

Kimberly Kayler contacted the Wisconsin Extension Office who advised delaying survey until next April/May timeframe due to pre-work needed to implement proper survey. Questions need to be Developed, recipients need to be identified

13. Status / Update: Multi-Dwelling Development Zoning Ordinance update:

Don Stover reported that the questionnaire sent to the Town's in May failed to pass. A new questionnaire was prepared, but it was requested to be reviewed/approved by the County Board at the June meeting. If approved it should be sent to the Town's in July.

14. Status / Update: TORL Water Testing Program 2024 update:

Don reported that 22 residents have signed up to date. The County will require 50 participants to make program worthwhile for them.

will be notified in June of status, award / deny.
